To follow up with Michael's email on March 11th, I've sat on this street and watched the following activating occur:

- March 12th - 8 different visitors in a 60min window
- March 13th - 6 different visitors in a 90min window
- March 14th - 9 different visitors in a 90min window
- March 15th - 12 different visitors in a 120min window
- March 17th - 7 different visitors in a 60min window

I basically spent some remote work hours watching the activity of this property and it's pretty clear that there is illegal activity happening here. What are the next steps we need to take as a community to get this resolved.

Good morning,

I have been tasked with looking into your complaint. I have driven by the location and did notice the trash on both sides of the ditch on 4600 Larkspur approximately 50 feet west from the Cullen Blvd intersection. I went ahead and took pictures and entered a service request with 311.

As for the drug trafficking issues coming from the residence located at 4650 Larkspur # A, my supervisor will get in contact with our Crime Suppression team or narcotics division to assign one of their officers to take lead on those issues.

Unfortunately, that area is one of the highest targeted areas for drug, prostitution and organized crime activity.

I will continue to go by the area and keeping track of the illegal dumping aspect of it with 311. Let me know if you need anything else from me.
